**Problematic**

The Sunnah is the second source of Islamic legislation after the Quoran, so the Islamic scholars since the first years had in the Hadith and Sunnah sciences a continuous work , sometimes memorize the Hadith , sometimes write it, Sometimes they Remove the suspicions on it, and sometimes they explain the general rules and principles that accept or reject the Hadith. In the forefront of these scholars the Imams of the doctrines who founded the jurisprudence schools that formed a great scientific movement, they put their origins and jurisprudence, and formed students who spread their knowledge and views where these schools contributed to finding appropriate solutions to all the problems and issues faced by Muslims in ancient and recently times, in all Islamic countries. Among these schools is the Hadith School established by the Imam Malik Ibn Anas, where he collected between deriving and knowledge of the Hadith .

The work on the Sunnah Nabawia and studying its fundamentals, meanings and its jurisprudence is one of the greatest and most important of what Muslims are engaged in, so how was the method of Imam Malik in the combination of Hadith and Fiqh? And how were the faces of influence of this method from his students and followers? What are the efforts of the Maalikis in this regard?
