- **5.** Ethical Considerations: Participants may engage in discussions about ethical considerations in the post-data collection phase, including issues related to data privacy, confidentiality, informed consent, and responsible conduct of research. Debates may arise regarding ethical dilemmas faced by researchers and strategies for addressing them ethically.
- **6.** <u>Time and Project Management</u>: Participants may discuss strategies for effectively managing time and resources during the post-data collection phase. Debates may center on prioritization of tasks, overcoming procrastination, managing stress, and maintaining work-life balance.
- 7. <u>Peer Feedback and Collaboration</u>: Participants may explore the benefits of peer feedback and collaboration in the post-data collection phase. Discussions may focus on strategies for seeking and providing constructive feedback, forming peer support networks, and leveraging collaborative opportunities to enhance research outcomes.
